Our website has become more informative and interactive with the new upgrade. Our app will also be updated soon.



What is new in Adoption Regulations 2017

(effective from 16.01.2017)

- Procedures related to adoption by relatives both within the country and abroad have been defined in the Regulations.
- > Validity of Home Study Report has been increased from two to three years.



- The time period available to the domestic PAP (s) for matching and acceptance, after reserving the child referred, has been increased to twenty days from the existing fifteen days.
- > District Child Protection Unit (DCPU) shall maintain a panel of professionally qualified or trained social workers.
- There are 32 Schedules annexed to the Regulations including model applications to be filed in the Court and this would considerably address delays prevalent in obtaining the Court order.
- CARA shall be facilitating all adoptions under JJ Act, 2015 through the Child Adoption Resource Information & Guidance System (CARINGS) and all kinds of adoptions, including adoptions by relatives shall be reported to CARA which would enable safeguards for all adopted children by maintaining their record and ensuring post adoption follow up. CONSENT

In health care, consent refers to the process whereby the patient and the healthcare practitioner engage in a dialogue (own simplified language) about a proposed medical treatment's nature, consequences, harms, benefits, risks and alternatives.

It improves patients' outcome with effective physician – patient communication and increased patient empowerment and preventing medical errors.

The documents a patient signs or puts a thumb impression to verify that he/she has engaged in a dialogue with a health care practitioner about a proposed medical treatment is commonly referred to as an "informed consent".



An informed consent process consists of seven elements

- 1. Discussing the patient's role in the decision making process.
- 2. Describing the clinical issue and suggested treatment
- 3. Discussing alternatives to the suggested treatment.
- 4. Discussing risks and benefits of the suggested treatment.
- 5. Discussing related uncertainties
- 6. Assessing the patient's understanding of the information provider.
- 7. Eliciting the patients' preference.


Today the law requires that a separate informed consent is necessary for every procedure involved in the patients' management. Separate consent for surgery, anesthesia, blood transmission etc must be obtained. Parents or guardians can sign the consent for a child (18 and below). Husband or any related cannot give the consent for family planning surgery, uterus removal etc. Only the patient has to give the consent

Improved communication between practitioners and patients leads to improved patient outcomes, less medical errors and lower rates of malpractice claims - a move firmly linked to patient satisfaction.


